Closed Session: Board to consider entering Executive Session under Section 551.071, 551.072 and 551.087 of the Texas Government Code, for a consultation with an attorney, the deliberation of the purchase, exchange, lease, and/or value of real property located within the City of Sweetwater related to a proposed project and to discuss commercial and/or financial information received by SEED MDD related to a business prospect seeking to located within the City of Sweetwater. No action will be taken during the Executive Session, as the law does not permit it.
